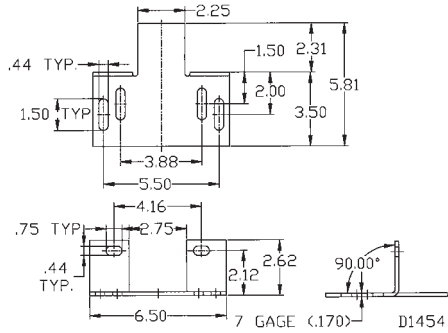
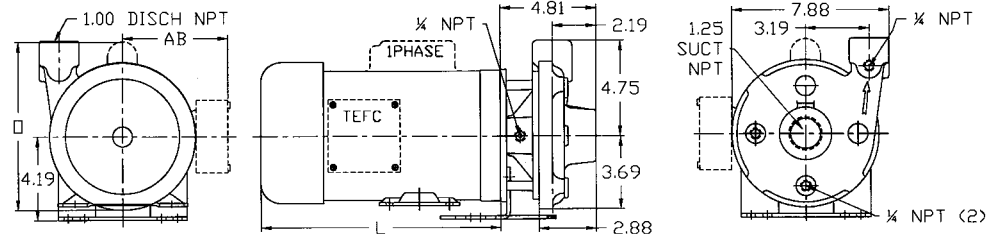

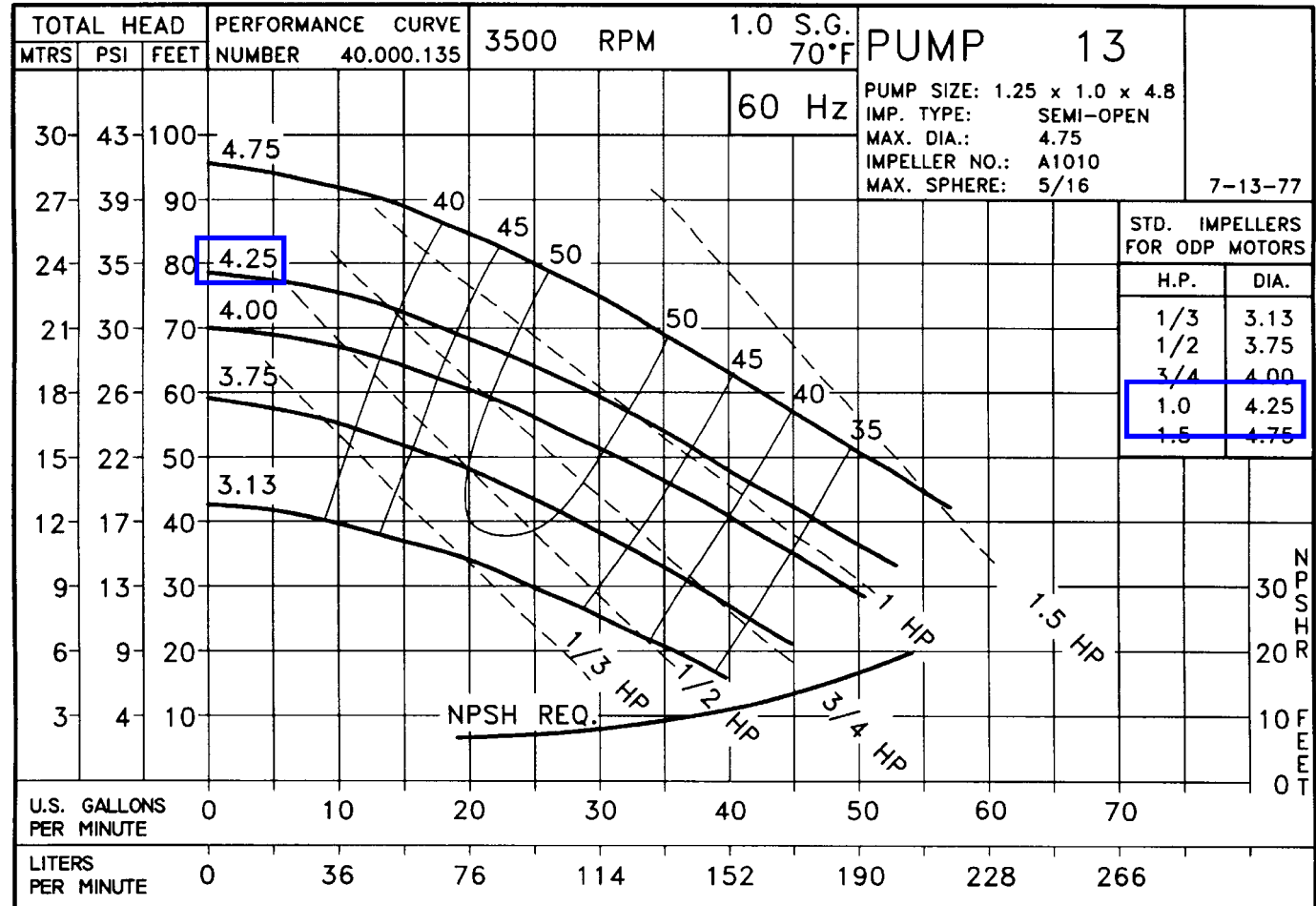

SBS WARRANTS that all products furnished hereunder will be free from defects in materials and workmanship for one year from the date of shipment and **WHEN OPERATED AND MAINTAINED UNDER DESIGN CONDITIONS AND IN ACCORDANCE WITH SBS' INSTRUCTIONS, WILL PERFORM IN ACCORDANCE WITH APPLICABLE ATTACHED SPECIFICATIONS FOR ONE YEAR FROM DATE OF SHIPMENT.** If within such one year period any product or portion thereof proves, after receipt of prompt notice and inspection by SBS, to be defective as to materials or workmanship, SBS will, at its option, either repair or replace any such product or portion thereof at the job site.
